Robert Charles Kinyon was born on October 17th, 1965. Relocating to the Bay Area after growing up in a small rural town in Southern California, Mr. Kinyon focused his early ambitions on formal liberal arts becoming a self taught accountant. As time went by, a love of creation and nature developed and Designs by Kinyon was born. As before, Robert is self taught or mentored by his beloved matriarchs (Patricia Kinyon, Nancy Butler and Shirley Brewton). Early mediums include carpentry, floral design and needlework. Robert has done everything from the design aspect to selling his creations within the San Francisco Bay Area. He has pieces on display permanently at UCSF Medical Center Parnassus.

1 Describe your work in detail How do you make it?

With acrylic pouring projects, I wet my stretched canvas with my base coat. I mix all of my colors with a paint conditioner or medium and add water until the mixture is consistent to heavy whipping cream. I layer the paints in a new container to perform a dirty flip, remove bubbles, hair and lint. Once fully dry, I coat the project with epoxy resin. With faux geode projects, I cut my wood to the correct size and shape, sand and seal. I paint the front and back base colors. I perform epoxy resin and/or acrylic pouring techniques and hot glue crystals. I attach gems, crystals and glitter glass with epoxy resin. I embellish the edges and the back of the projects. All projects get signed and dated. The backs are professionally finished and eyelets and wire are installed for hanging.

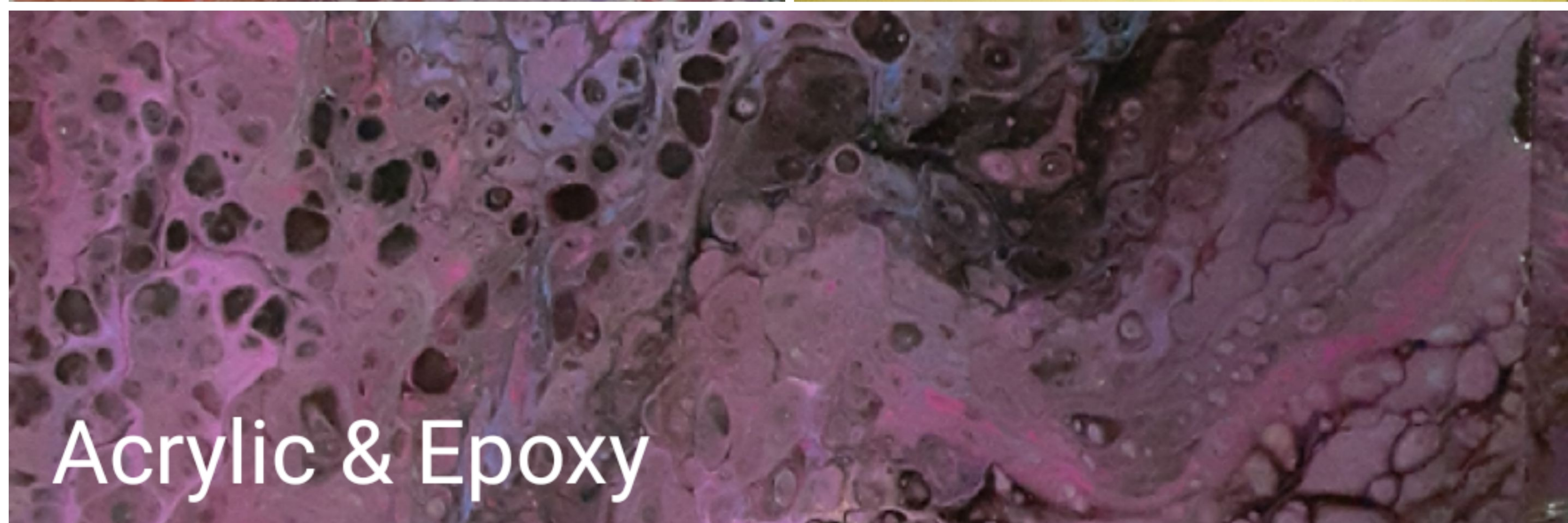
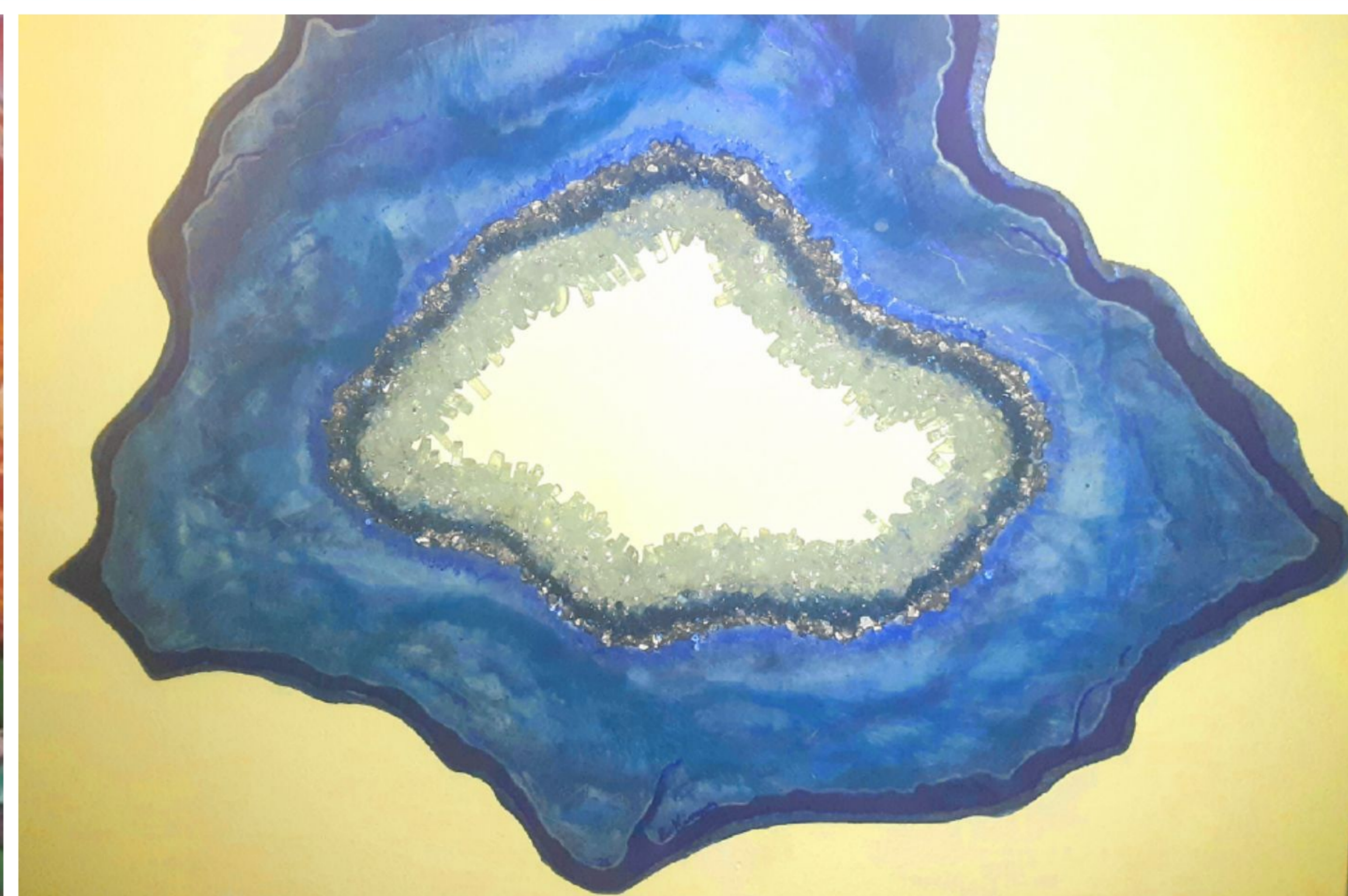
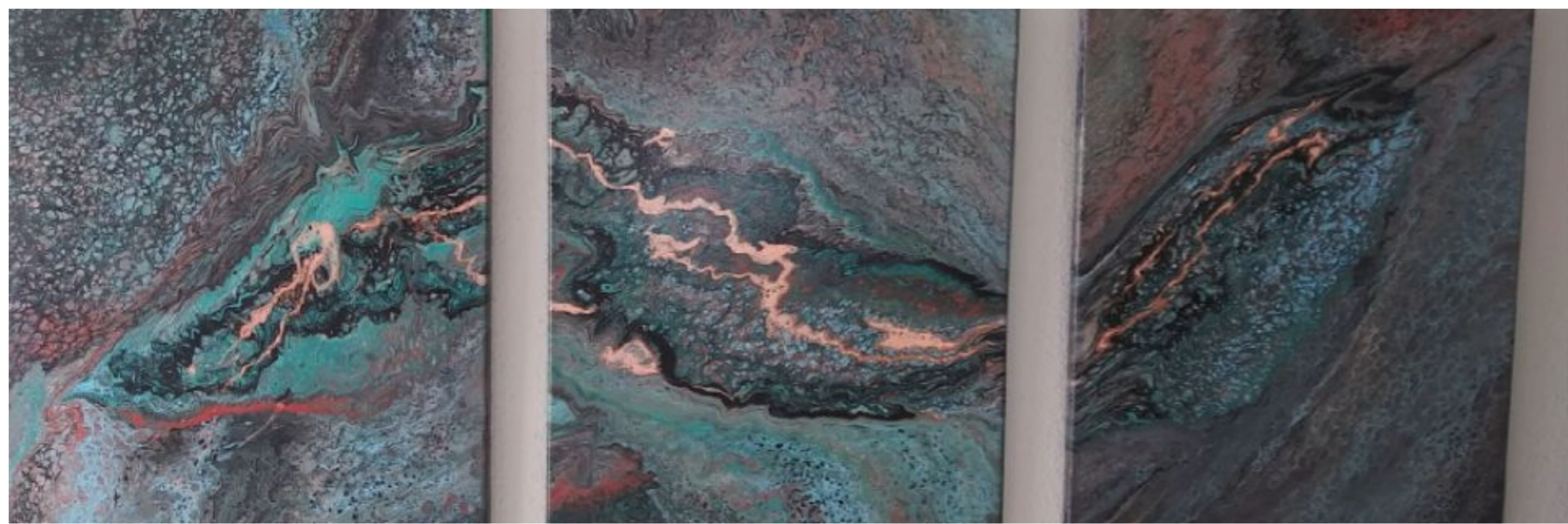
