Updated Resolution for CA SB 1012 - Psychedelic Facilitators Act and the Regulated Psychedelic-Assisted Therapy Act. During the April meeting it was noted the resolution did not match the amended version of the bill. An updated version, revised by Commissioner Kutovaya, will be reviewed by the Commission.
