

### MEETING OF THE FULL ARTS COMMISSION

Monday, April 1, 2024 2 p.m. Hybrid Meeting

#### **Minutes**

President Collins called the meeting to order at 2:20 p.m.

President Collins asked for any agenda changes and no changes were suggested.

President Collins announced the public meeting instructions.

Commission Secretary Dhaliwal announced public comment instructions.

President Collins began the meeting by reading the Arts Commission's land acknowledgment statement.

### 2. Approval of the Minutes (6:10)

Commissioner Brenzel, seconded by Commissioner Beltran moved to approve the March 4, 2024, minutes.

There was no public comment.

The motion was unanimously approved.

### 3. General Public Comment (7:23)

#### Public Comment:

Michael Jankosky, on the American Guild of Musical Artists Board, singer with San Francisco Opera Chorus and San Francisco Symphony Chorus. He mentioned the contract for the music director of the San FranciscoSymphony was not being renewed due to the director's vision being misaligned of that of the boards. He spoke about the difficulties of art institutions acting like for-profit organizations. He noted that he wants



representation for working artists on the board level.

There was no additional public comment.

## 4. Director's Report (11:22)

Director Remington announced Jeanne Anyanwu McCoy has resigned as commissioner from the San Francisco Arts Commission. He thanked Ms. McCoy and wished her the best in future endeavors. He stated that they will work with the Mayor's office to fill McCoy's role. He shared that he attended the following events: a reception honoring Irving Penn and Fashioning San Francisco on March 14, The Ink of Identify: Rereading Afghanistan by Gazelle Samizay screening video on March 16, the California College of the Arts 2024 Gala honoring Jack Wadsworth on March 21, opening of a new body of work of Rachel Jones on March 26, spoke at the American Indian Cultural District Annual Town Hall and attended Sign my name to Freedom musical opening on March 29.

Director Remington shared that the Community Investments team wrapped up their Cultural Services Allocation Plan (CSAP) community outreach. He noted that consultant AMS are working on analyzing the data and feedback received and looks forward to sharing the findings and recommendation for the 2025 – 2029 CSAP. Director Remington continued with providing Gallery updates. He mentioned that *Conversation 8: Harry Doge and Alicia McCarth*y is currently on view at the SFAC Main Gallery through April 27. He noted that SFAC's exhibition on the Ground Floor of City Hall, *A Public Voice/Una Vos Publica* is temporarily down through April 3, 2024, the exhibition has been extended through September 27, 2024.

Director Remington mentioned that the Public Art team has unveiled the first 2024 Art on Market Street Poster Series, which will showcase the culture and art of the Bay Area's Native community. He explained the series was created by artist Jesse Hernadez and featured six posters of Bay Area's indigenous sacred animals which include the Eagle, Coyote, Bear, Hawk, Deer, and Otter. He continued that Jesse Hernandez's vibrant posters help highlight the native language by featuring the traditional



names of each animal in a modern and striking way that pays homage to style of street art that bridge past, future and present. He noted the posters are on view along Market Street between 7th and Stewart Street through June 2024.

Director Remington said there is a call for artists to submit qualifications for the 11th and Natoma Park project to design perimeter fence panels. He explained San Francisco Recreation and Parks (RPD) plans to install 11-foot high, powder-coated aluminum perimeter fence and entry gate along the 11th street frontage of the park which provides an opportunity for the integration of a permanent public artwork. He shared artists will be responsible specifically for the design of up to 1300 square feet of panels. He mentioned the deadline to submit qualifications is May 1, 2024, by 11:59 p.m. He shared that temporary exhibition in Particia's Green, *Cathenge* will soon be coming down, the installation by artist David Normal has been on view for the past 16 months and features 6 illuminated 3D printed cat sculptures or "Catholiths". He noted staff are working on selecting the next installation that will be featured in Patricia's Green.

Director Remington noted a consultant has been recently chosen to lead an upcoming equity audit of monument and memorials, additional publicly sited artworks in the civic art collection, with details being finalized. He acknowledged consultant AECOM are no longer able to work on the strategic plan project due to internal organizational changes, and action has been taken to secure a new consultant team. He shared that the courts have granted a temporary restraining order against a public member who has made threats to San Francisco Arts Commission.

There was no public comment.

# 5. Committee Reports and Committee Matters (21:47)

1. Civic Design Review Committee (21:56)

Committee Report for Civic Design Review was tabled for the next



Full Commission meeting.

### 2. Visual Arts Committee (22:05)

Chair Suzie Ferras reported the approval of a new public art project at the new, yet to be named, half-acre, 11th & Natoma Park, in the South of Market neighborhood, which is located in the southwest corner of SOMA's Filipino Cultural Heritage District and one block from the Leather and LGBTQ Cultural District. She mentioned the artist will be responsible for the design of up to 1300 square feet of fence, which will be fabricated and installed by a separate contractor paid for and managed by the Recreation and Park Department (RPD) park project. She noted the total Art Enrichment budget is \$110,000 and the design only artist contract budget is \$25,000. She shared the Request for Qualifications (RFQ) was posted March 26th and is open to all artists or artists teams who reside in the United States and recruitment will focus on artists with a meaningful connection to SOMA.

Chair Ferras mentioned the completed artwork *Whorl Whirl: Or Circular Nature* by artist Norie Sato was presented. She said the artist was selected in 2016 with the design being approved in 2019. She shared the artwork is 335 ft. long and up to 30 ft. tall. She included that the artwork uses a circular vortex motif to reference the complex and regenerative process that occurs at the Headworks Facility at the Southeast Treatment Center which processes 80% of the city's wastewater. She continued that Sato highlights the cyclical movement of water from dirty to clean in the brightly colored aluminum fins that transition from dark to light to dark again, the movement is also represented in the perforated steel panels behind the fins.

There is no public comment.

### 3. Executive Committee (26:34)



President Collins reported that a motion was approved for the consent calendar of a location change for Executive Committee meetings to move to City Hall. He spoke about the Sole Source Solicitation Waiver: Gay Lesbian Bisexual transgender (GLBT) Historical Society being approved for the consent calendar. He noted the StreetsmARTS Mural Program Artist Pool being approved for the consent calendar.

### 6. SFAC Galleries Mentorship & Exhibition Fellowship (33:04)

Director of Galleries and Public Programs Carolina Aranibar-Fernandez presented on SFAC Galleries Mentorship & Exhibition Fellowship.

Director Aranibar-Fernandez shared the new Mentorship & Exhibition Fellowship program is designed to support emerging artists in the Bay Area by providing resources and space for meaningful professional development, culminating in an exhibition at the SFAC Main Gallery opening in September 2024. She mentioned a grant given to support the project. She continued that earlier in the year they held a request for qualifications for emerging artists for the program with an aim to choose two artists, one artist based in San Francisco and the other based in the bay area. She noted that they received 169 applications and chosen artists Shirin Khalatbari and Sun Park. She included information about the curator and mentor Shirin Makaremi.

There was no public comment.

Commissioner Brenzel brought to attention that subitem 3 had not been posted, which would result in tabling until the next Full Commission.



President Collins mentioned that subitems 9 and 34 would need a recusal from Commissioner Ferras, however with the recusal quorum would be lost. Subitems 9 and 34 have been tabled until next Full Commission.

President Collins is moving subitem 33 out of the consent calendar and into its own item for discussion and possible action.

Commissioner Beltran, seconded by Commissioner Brenzel moved to approve all consent calendar items with the exception of item 3, 9, 33, and 34.

There was no public comment.
