For your reference, the relevant provisions of Elections Code section 13107 are reproduced below:

- (a) With the exception of candidates for Justice of the State Supreme Court or court of appeal, immediately under the name of each candidate, and not separated from the name by any line, unless the designation made by the candidate pursuant to Section 8002.5 must be listed immediately below the name of the candidate pursuant to Section 13105, and in that case immediately under the designation, may appear at the option of the candidate only one of the following designations:
- (1) Words designating the elective city, county, district, state, or federal office which the candidate holds at the time of filing the nomination documents to which the candidate was elected by vote of the people.
- (2) The word "incumbent" if the candidate is a candidate for the same office which the candidate holds at the time of filing the nomination papers, and was elected to that office by a vote of the people. A candidate shall not use the word "incumbent" if the candidate was elected to their office in an at-large election and is a candidate in a district-based election.
- (3) No more than three words designating either the current principal professions, vocations, or occupations of the candidate, or the principal professions, vocations, or occupations of the candidate during the calendar year immediately preceding the filing of nomination documents.
- (4) The phrase "appointed incumbent" if the candidate holds an office by virtue of appointment, and the candidate is a candidate for election to the same office, or, if the candidate is a candidate for election to the same office or to some other office, the word "appointed" and the title of the office. In either instance, the candidate may not use the unmodified word "incumbent" or any words designating the office unmodified by the word "appointed." However, the phrase "appointed incumbent" shall not be required of a candidate who seeks reelection to an office which the candidate holds and to which the candidate was appointed, as a nominated candidate, in lieu of an election, pursuant to Sections 5326 and 5328 of the Education Code or Section 7228, 7423, 7673, 10229, or 10515 of this code.
- (b) (1) Except as specified in paragraph (2), for candidates for judicial office, immediately under the name of each candidate, and not separated from the name by any line, only one of the following designations may appear at the option of the candidate:
- (A) Words designating the city, county, district, state, or federal office held by the candidate at the time of filing the nomination documents.
- (B) The word "incumbent" if the candidate is a candidate for the same office that the candidate holds at the time of filing the nomination papers.
- (C) No more than three words designating either the current principal professions, vocations, or occupations of the candidate, or the principal professions, vocations, or occupations of the candidate during the calendar year immediately preceding the filing of nomination documents.
- (2) For a candidate for judicial office who is an active member of the State Bar employed by a city, county, district, state, or by the United States, the designation shall appear as one of the following:
- (A) Words designating the actual job title, as defined by statute, charter, or other governing instrument.
- (B) One of the following ballot designations: "Attorney," "Attorney at Law," "Lawyer," or "Counselor at Law." The designations "Attorney" and "Lawyer" may be used in combination with one other current principal profession, vocation, or occupation of the candidate, or the principal profession, vocation, or occupation of the candidate during the calendar year immediately preceding the filing of nomination documents.
- (3) A designation made pursuant to subparagraph (A) of paragraph (1) or paragraph (2) shall also contain relevant qualifiers, as follows:
- (A) If the candidate is an official or employee of a city, the name of the city shall appear preceded by the words "City of."
- (B) If the candidate is an official or employee of a county, the name of the county shall appear preceded by the words "County of."
- (C) If the candidate is an official or employee of a city and county, the name of the city and county shall appear preceded by the words "City and County."
- (D) If the candidate performs quasi-judicial functions for a governmental agency, the full name of the agency shall be included.
- (c) A candidate for superior court judge who is an active member of the State Bar and practices law as one of the candidate's principal professions shall use one of the following ballot designations as the candidate's ballot designation: "Attorney," "Attorney at Law," "Lawyer," or "Counselor at Law." The designations "Attorney" and "Lawyer" may be used in combination with one other current principal profession, vocation, or occupation of the candidate, or the principal profession, vocation, or occupation of the candidate during the calendar year immediately preceding the filing of nomination documents.
- (d) For purposes of this section, all California geographical names shall be considered to be one word. Hyphenated words that appear in any generally available standard reference dictionary, published in the United States at any time within the 10 calendar years immediately preceding the election for which the words are counted, including a generally available standard reference dictionary published online, shall be considered as one word. Each part of all other hyphenated words shall be counted as a separate word.
- (e) The Secretary of State and any other elections official shall not accept a designation of which any of the following would be true:

- (1) It would mislead the voter.
- (2) It would suggest an evaluation of a candidate, such as outstanding, leading, expert, virtuous, or eminent,
- (3) It abbreviates the word "retired" or places it following any word or words which it modifies.
- (4) It uses a word or prefix, such as "former" or "ex-," which means a prior status. The only exception is the use of the word "retired."
- (5) It uses the name of any political party, whether or not it has qualified for the ballot.
- (6) It uses a word or words referring to a racial, religious, or ethnic group.
- (7) It refers to any activity prohibited by law.
- (f) If, upon checking the nomination documents and the ballot designation worksheet described in Section 13107.3, the elections official finds the designation to be in violation of any of the restrictions set forth in this section, the elections official shall notify the candidate by registered or certified mail return receipt requested, addressed to the mailing address provided on the candidate's ballot designation worksheet.
- (1) The candidate shall, within three days, excluding Saturday, Sunday, and state holidays, from the date the candidate receives notice by registered or certified mail, or from the date the candidate receives actual notice of the violation, whichever occurs first, appear before the elections official or, in the case of the Secretary of State, notify the Secretary of State by telephone, and provide a designation that complies with subdivision (a) or (b).
- (2) If a candidate fails to provide a designation that complies with subdivision (a) or (b) within the three-day period specified in paragraph (1), a designation shall not appear after the candidate's name.
- (g) A designation given by a candidate shall not be changed by the candidate after the final date for filing nomination documents, except as specifically requested by the elections official as specified in subdivision (f) or as provided in subdivision (h). The elections official shall maintain a copy of the ballot designation worksheet for each candidate that appears on the ballot in the county for the same period of time as applied to nomination documents pursuant to Section 17100.
- (h) The designation shall remain the same for all purposes of both primary and general elections, unless the candidate, at least 98 days before the general election, requests in writing a different designation which the candidate is entitled to use at the time of the request.
- (i) In all cases, the words so used shall be printed in a manner consistent with the space requirements of Sections 13207 and 13211.
- (j) If a foreign language translation of a candidate's designation is required under the federal Voting Rights Act of 1965 (52 U.S.C. Sec. 10101 et seq.), as amended, to appear on the ballot in addition to the English language version, it shall be as short as possible, as consistent as is practicable with this section, and shall employ abbreviations and initials wherever possible in order to avoid undue length.

For your reference, Elections Code section 13107.3 is reproduced below:

- (a) A candidate who submits a ballot designation pursuant to subdivision (a) of Section 13107 shall file a ballot designation worksheet that supports the use of that ballot designation by the candidate, in a format prescribed by the Secretary of State.
- (b) The ballot designation worksheet shall be filed with the elections official at the same time that the candidate files his or her declaration of candidacy.
- (c) In the event that a candidate fails to file a ballot designation worksheet in accordance with subdivision (a), no designation shall appear under the candidate's name on the ballot.

For your reference, Elections Code section 13107.5 is reproduced below:

- (a) A candidate's ballot designation as "community volunteer" shall constitute a valid principal vocation or occupation for purposes of subdivision (a) of Section 13107, if not otherwise in violation of any of the restrictions set forth in that section, and subject to the following conditions:
- (1) A candidate's community volunteer activities constitute his or her principal profession, vocation, or occupation.
- (2) A candidate is not engaged concurrently in another principal profession, vocation, or occupation.
- (3) A candidate may not use the designation of "community volunteer" in combination with any other principal profession, vocation, or occupation designation.
- (b) The Secretary of State shall by regulation define what constitutes a community volunteer for purposes of this section.

For your reference, California Code of Regulations section 20711 is reproduced below:

- (a) In order to facilitate review of a candidate's proposed ballot designation by the Secretary of State pursuant to Elections Code § 13107, the candidate shall submit, at the time of filing his or her proposed ballot designation on the Declaration of Candidacy, a completed Ballot Designation Worksheet on a form provided by the Secretary of State.
- (b) All Ballot Designation Worksheets filed with the Office of the Secretary of State or the county elections officials pursuant to this section shall be public records and shall be available for inspection and copying at the public counter of the Elections Division of the Office of the Secretary of State, Fifth Floor, 1500 11th Street, Sacramento, California 95814, or at the office of the applicable county elections official.
- (c) The Secretary of State shall provide a master copy or copies of the Ballot Designation Worksheet to all elections officials responsible for providing and accepting the nomination documents for candidates in elections for offices certified by the Secretary of State. The Ballot Designation Worksheet shall request that the candidate proposing the ballot designation provide the following information:
- (1) The candidate's name, home, business and mailing addresses, telephone numbers, e-mail address, if available, and fax number;
- (2) A designation of the office for which the candidate is seeking election;
- (3) The name, home, business and mailing addresses, telephone numbers, e-mail address, if available, and fax number of the attorney representing the candidate or for any other person to be contacted in the event the Secretary of State requires further information regarding the proposed ballot designation;
- (4) The proposed ballot designation submitted by the candidate;
- (5) The candidate may submit one or more proposed alternate ballot designations ranked in order of the candidate's preference;
- (6) A brief statement identifying the factual basis upon which the candidate claims the proposed ballot designation and each proposed alternate ballot designation, including the following:
- (A) If the candidate holds elected office and is submitting his or her proposed ballot designation pursuant to Elections Code § 13107, subdivisions (a)(1) or (a)(2), the candidate shall indicate the elective office he or she currently occupies and may attach a copy of his or her Certificate of Election;
- (B) If the candidate is a judicial officer and is submitting his or her proposed ballot designation pursuant to Elections Code § 13107, subdivisions (a)(1) or (a)(2), the candidate shall indicate the elective office he or she currently holds and may attach either (A) a copy of his or her Certificate of Election or (B) a copy of his or her commission or certificate of appointment, issued at the time the candidate was appointed to the judicial office which he or she currently occupies;
- (C) If the candidate submits a ballot designation pursuant to Elections Code § 13107, subdivision (a)(3), the candidate shall indicate:
- (i) The title of the position or positions which he or she claims supports the proposed ballot designation;
- (ii) The dates during which the candidate held such position;
- (iii) A description of the work he or she performs in the position;
- (iv) The name of the candidate's business or employer;
- (v) The name and telephone number of a person or persons who could verify such information; and
- (vi) A statement that the professions, vocations or occupations relied upon to support the proposed ballot designation constitute the primary, main or leading professions, vocations or occupations of the candidate, in accordance with the definition of the term "principal" as set forth at § 20714, subdivision (b).
- (D) If the candidate submits a ballot designation pursuant to Elections Code § 13107, subdivision (a)(4), the candidate shall indicate the date on which he or she was appointed to the office for which he or she is an appointed incumbent.
- (d) The candidate may attach or append any supporting documents or other exhibits to his or her Ballot Designation Worksheet which he or she believes support his or her proposed ballot designation. Such attached documents or other exhibits shall be deemed to be incorporated by reference as part of the candidate's Ballot Designation Worksheet and shall be considered as such by the Secretary of State.
- (e) If a candidate requests a change of his or her ballot designation pursuant to Elections Code § 13107(e), that request shall be accompanied by a Ballot Designation Worksheet.





To court SF voters, politicians give themselves flowery Chinese names

When San Francisco Supervisor Dean Preston ran for reelection in 2020, he changed his name on the ballot—not his English one, but his Chinese identity.

Preston, who is of German descent, requested to appear on the ballot as "潘正義," which means "Justice Pan" in Chinese. Previously, he was "迪恩·普瑞斯頓" on the ballot, a long and transliteration-based Chinese name.

An outspoken advocate for tenants' rights and other progressive-leaning causes, Preston's choice of "Justice" as his name was perhaps obvious—if a bit superhero-esque. "Pan," on the other hand, is simply a Chinese surname that starts with the letter P.

"I think that [my Chinese name's] relevance has increased," Preston told The Standard. "There are a lot of Asian residents in my district now."

Since redistricting drew the Tenderloin into Preston's district in 2022, approximately 20% of his constituents are Asian American. Citywide, Chinese Americans comprise approximately one-fourth of the population. This demographic fact leads to local election

ballots being, by default, bilingual in English and Chinese and starting from 1999, candidates will appear with Chinese names.

Traditionally, political candidates who are not of Chinese ancestry have appeared on the ballot with a Chinese name based on their English names' phonetic transliteration—many of these could be a long and awkward moniker of five, six or more characters, written with a dot between the given name and surname (something never done with typical Chinese names).

But now, aspiring officeholders are being much more deliberate about selecting an "authentic" Chinese name—normally three characters, with a Chinese surname first, and two characters as given name.

For monolingual Chinese voters, a three-character Chinese name can be easier to remember than a longer, transliterated name. Having a Chinese name that rolls off the tongue can help a candidate boost their name recognition in Chinese media.

Everybody's Doing It

Vice President Kamala Harris appears to be one of the first to start this trend when she first ran for San Francisco district attorney in 2003, according to Chinese-language media. Harris ditched the transliteration-based name 哈里斯 ("ha lay si") and chose 賀錦麗 ("ho gum lai") instead. To Cantonese speakers' ears, the new appellation had a more celebratory and positive ring (the surname Ho, 賀, means "celebrate"), while Gum-Lai has a feminine quality (錦麗 means "beautiful").

Candidates for San Francisco's school board, City College board and the BART board are no exception—having a three-character Chinese name is now the norm.

It's hard to measure the actual impact of an "authentic" Chinese name on the ballot, because there is no official data on how many Chinese-reading voters call San Francisco home. But according to U.S. Census data, about 184,000 people of Chinese descent live in San Francisco, and among them, 118,000 are foreign-born. Presumably, a large number of those immigrants can read Chinese—and some American-born Chinese can, too.

Department of Elections data shows that 95% of San Francisco voters receive the English and Chinese bilingual ballot. The other 5% requested non-English, non-Chinese language ballots like Spanish or Tagalog. About 30,000 voters requested the Chinese-language Voter Information Pamphlet (選民資料手冊), about 6% of total voters.

Who Gets To Name You?

Karen Gee, an immigrant from Guangzhou who lives in San Francisco's Portola neighborhood, is the go-to name-giver for many progressive political candidates in the city.

She has bestowed Chinese names on elected officials including State Assemblyman Matt Haney and Supervisor Shamann Walton. Gee's daughter, Natalie, is the chief of staff for Walton.

Gee said that she loves Chinese literature, and selecting Chinese names for others is a way for her to share the beautiful Chinese language and culture.

Gee explained that she chose Haney's Chinese name, 楊馳馬, because the second two characters mean "running horse," hinting that he would run like a horse in the race and win. And, the pronunciation for horse is "ma," which is close in sound to his first name, Matt.

Natalie Gee, who's fluent in Chinese, has also given out some Chinese names as well. Preston's "Justice Pan," for example, was her creation.

Mayor London Breed doesn't have an "authentic" Chinese name but a five-character, phonetic, transliteration-based name. She has two characters, 储敦, that approximate the sound of "Breed" or "bow lay dak." This major difference is that this type of name doesn't have a typical Chinese surname like Chan, Zhang or Hc.

Breed previously said that she grew up with Chinese American friends who speak Cantonese, and her high school friend gave her the name. Aaron Peskin, president of the Board of Supervisors, also has gone for a phonetic transliterated name, 佩斯金 (pui see gum).

Election Rules

When a candidate submits a form to run for office in San Francisco, they have to answer a question: Do you want the Department of Elections to make you a Chinese name, or do you have one already?

Catherine Lee, a manager of the voter information division at the department, is the de facto gatekeeper, tasked with reviewing candidates' submissions. An immigrant from Hong Kong and a former news anchor, Lee speaks fluent Cantonese.

She has a few rules. The submitted names have to be in traditional Chinese, which is used in Hong Kong, Taiwan and some overseas Chinese communities while mainland China uses simplified Chinese. They cannot be the same as historic figures or celebrities. They cannot lead to ambiguity or become too promotional.

Lee added that she likes to ask candidates to provide some examples of Chinese media coverage showing the candidate's Chinese name has been circulated by the press.

In 2022, when former police commissioner John Hamasaki ran for district attorney, he wrote his Chinese name on the filing forms and attached an article from the Sing Tao Daily proving that's how Chinese media referred to him.

But in Preston's case, his Chinese name initially met some challenges. When he ran for supervisor in 2019, the name "Justice Pan" was rejected on the grounds that it was too positive, and the department considered it unfair to his opponents. Plus, Preston had never used it before. However, Preston won the election and continued to use Justice Pan in the Chinese press, so election officials exempted him, and let him use it on the 2020 ballot.

In 2019, Assemblymember Evan Low authored <u>legislation</u> to regulate Chinese translations on California's statewide ballots. The law mandates that candidates use transliteration-based names unless they can prove that they were <u>born with a character-based name</u> or

have been using such an "authentic" style Chinese name for at least two years.

San Francisco's Department of Elections has rules that slightly differ from Low's legislation and has insisted his law doesn't apply to local races, which means candidates do not need to prove that two-year usage. The City Attorney's Office didn't respond to a request for comment.


Supervisor Connie Chan, an immigrant from Hong Kong, said she's considering actions on the board to implement Low's bill at the local level.

"We need to recognize Asian heritage," Chan said, "and a person's name indicates who they are and their heritage."

Chan, as the only Chinese American supervisor on the board, slammed some candidates for trying to trick voters with their Chinese names.

"We see that there are times where candidates are using the Chinese name as a way to mislead voters to let them think that they are of Chinese descent," she told The Standard.

Voting for a Chinese Name?

Nevertheless, Chan has bestowed an "authentic" Chinese name on one of her colleagues: Supervisor Matt Dorsey, or 麥德誠. She cited Dorsey's long history of public service as a communication expert and his connections with Chinese-language media as the reason she did it for him.

Chinese American identity politics have become far more complicated in San Francisco politics in recent years. By unseating Supervisor Gordon Mar last year in a race that surprised many observers, Joel Engardio, a white man, also ended a long, unbroken chain of <u>Chinese American supervisors in the Sunset District</u>. Many Chinese American voters said that they used to vote for whomever had an Asian name, but now <u>they take other factors into consideration</u>.

Even so, many potential candidates have decided to pursue a Chinese name, too. Trevor Chandler, who <u>announced a run for District 9</u> supervisor in the <u>2024 election</u>, also got himself a brand-new Chinese name, 陳澤維, which is pronounced "chun zak wai" in Cantonese, picking the surname Chan because it's similar to "Chandler" and "zak wai" because it's close to "Trevor."

Another potential candidate for that race, Roberto Hernandez, confirmed with The Standard that his new Chinese name is 何保行; the last two characters mean "protect walking."

Jackle Fielder, who has also mulled a run for District 9, said she's had a Chinese name since 2020. That year, Fielder ran a high-profile campaign against state Sen. Scott Wiener, and the local election department at that time refused to print her submitted Chinese name, 福天亮 (fuk tin leung), because she hadn't used it for two years for a state office race.

But for 2024, she plans to submit that name again for the ballot, because the name connects to her Native American name, "nagsháawi." An enrolled member of the federally recognized Three Affiliated Tribes, she is ethnically Hidatsa and chose to honor that heritage.

"It means 'dawn' or 'daybreak," Fielder said of both her native name and her Chinese name, 天亮. "It shows a big part of who I am."

Politicized during the 2014 Black Lives Matter demonstrations, Jackie Fielder has dedicated her life to organizing for racial and environmental justice. An Indigenous and Latina organizer and educator from Long Beach, Jackie lives in The Mission and considers herself a member of the wave of young, progressive politicians fighting to wrest power away from corporations and return it to the people.

Following the police crackdown on the No Dakota Access Pipeline protestors on her ancestral lands, Jackie co-founded the **San Francisco Public Bank Coalition** to fight for the divestment of city funds from the Wall Street banks that fund pipeline expansions.

Never content to work on just one thing, Jackie also co-managed the 2018 No on Prop H Campaign, which fought an expansive SFPD use of force policy. In 2020, Jackie launched a grassroots State Senate campaign. Though she didn't win, Jackie parlayed the political clout she gained to co-found Daybreak PAC, which endorses corporate-free, grassroots candidates for California state office.


Today, Jackie serves as the co-director of **Stop The Money Pipeline**, which advocates to hold the financial backers of climate change accountable, and as a commissioner on the Local Agency Formation Commission.

When asked how she continues to access hope despite key setbacks in

environmental and reproductive rights, Jackie points to organizing victories in Ecuador and Colombia that seemed unimaginable just 30 years ago. "It's become clear that this is an evolution way longer than an election cycle, even three election cycles," she said. And regardless of developments in federal politics, Jackie stays focused on transforming local politics so the unimaginable becomes reality. "It's all part of the marathon."

A groundbreaking California law will force large companies doing business in the state—including major global corporations—to disclose their planet-heating carbon emissions.

The measure, signed into law by the governor, Gavin Newsom, on Saturday, will be the nation's first of its kind, serving as a blueprint for national climate accountability. It comes as federal regulators have dragged their feet on crafting similar rules, which could be finalized this month.

SB 253 will require California regulators to create rules by 2025 for public and private companies whose annual revenues exceed \$1 billion. That affects about 5,300 corporations, including Chevron, Wells Fargo, Amazon, and Apple.

The new rules could "pull back the curtain on the biggest

By 2026, those companies will have to publicly disclose how much carbon is produced by their operations and electricity use. Critically, by 2027, they will also be required to report emissions generated by their supply chains and customers, known as "scope 3" emissions, which are highly controversial among business interests, including the fossil fuel industry.

climate destroyers in the oil industry and make it harder to greenwash."

A companion bill passed by the state's legislature, SB-261, would additionally require businesses with more than \$500 million in yearly revenue to disclose their climate-related financial risks beginning in 2026, or face annual penalties.

Both bills will make new data public beyond California's borders, which supporters say could be game-changing. "The disclosure requirements would really pull back the curtain on the biggest climate destroyers in the oil industry and make it harder to greenwash," said Hollin Kretzmann, a senior attorney at the environmental advocacy group Center for Biological Diversity, which supported the bills.

Yet Newsom's signatures came with caveats. In two similar signing statements, he raised concerns about the bills' implementation deadlines and the costs they will impose on businesses. He previously said approval would be subject to "some cleanup" in language, sparking concern that the laws will be weakened.

"I thank the governor and the bill authors for their leadership, but the hard work of implementing these laws must prove our shared commitment to California's climate leadership," said David Weiskopf, senior policy advisor at advocacy group NextGen.

The measures come as the Securities and Exchange Commission (SEC) finalizes a long-awaited, similar federal mandate. Last year, the agency proposed regulations that would likewise require publicly traded companies to notify investors of their emissions—including scope 3 emissions—and climate-related risks.

The bills faced staunch opposition from the state's chamber of commerce and powerful oil lobby, who argued they will lead to inaccurate reporting and create costs that could be passed on to customers.

This spring, fossil fuel giant Chevron spent \$1.27 million on lobbying in the state, according to disclosure records. The trade group Western States Petroleum Association spent \$2.38 million over the same period.

"The reporting requirements are unprecedented, undefined, and will do nothing to reduce emissions," said Kevin Slagle, Western States Petroleum Association's vice-president of strategic communications, declining to specify how much the association spent to fight the bills.

Spokesperson Bill Turenne said Chevron already voluntarily reports its emissions, including Scope 3, and "will continue our mandatory and voluntary financial disclosures in the jurisdictions where we operate."

Reports show oil companies' scope 3 reporting processes are inconsistent.

Marathon Petroleum, the California Independent Petroleum Association, and the American Chemistry Council also fought the bills, a new analysis from climate research group Sunstone Strategies shows, as did other fossil fuel interests.

Other business interests, however, joined environmental advocates in supporting the measures. Tech giants Apple, Google, Salesforce, Microsoft and Adobe backed it, as did businesses that tout their sustainability practices such as Ikea, Patagonia and Amalgamated Bank.

Ivan Frishberg, chief sustainability officer at Amalgamated Bank, which has published emissions and climate risk reports for years, said his firm's climate-focused practices have spurred more business. "We're making a lot of money by doing the right thing," said Frishberg.

Even companies whose focus is selling planet-heating products should realize more climate disclosure is on the way, he said.

The EU has already adopted regulations mandating climate disclosure by large companies doing business there and is building out additional requirements, which could apply to many companies affected by the California laws.

The SEC chair, Gary Gensler, said the measures could "change the baseline" for the long-awaited federal rule.

"If those companies were reporting to California, then it would be in essence less costly because they'd already be producing that information," he said during a house oversight hearing last month.

The agency has faced pressure to weaken its proposal from oil interests including ConocoPhillips, Phillips 66, and trade group the American Petroleum Institute.

The opposition will likely be "renewed and vigorous" in the wake of the California victories, said Jackie Fielder, co-director of the corporate accountability coalition Stop the Money Pipeline.

Advocates say the statewide fight should show federal regulators not to cave to meet polluters' demands. In California, lawmakers amended both bills to delay phase-in dates, lessen noncompliance penalties, and reduce the frequency of reporting requirements, but could not win oil companies' support. "The big lesson is that the fossil fuel industry aren't good faith negotiators," said Kretzmann.

Krestzmann said the bill shows California can be a "climate leader." Last month, Newsom also brought a much-lauded lawsuit against oil companies for allegedly misleading the public about the climate crisis.

But the governor could go even further, said Kretzmann, by imposing additional requirements for fossil projects or even directing regulators to halt new oil and gas permits altogether.

Advocates will be closely watching for changes to the legislation. Last month, Newsom said his staff would do "some cleanup on some little language" on the bills without specifying his desired changes. "That definitely made us raise our eyebrows," said Fielder.

Newsom has not stated plans to remove scope 3 requirements or otherwise weaken the measures, but will likely face pressure to do so. California's chamber of commerce says it will push for language tweaks to help protect business interests, which could signal a desire to "gut" the disclosure policy, bill author Scott Weiner told Politico.

"We'll be watching," Fielder said.





Stop the Money Pipeline Coalition Members Respond to Citigroup's New Climate Targets

WASHINGTON - Today Citigroup launched its initial roadmap to achieve net-zero in its energy and power portfolios. With these targets, Citigroup becomes the first major US bank to set an absolute emissions target for its energy portfolio.

Climate advocates have repeatedly criticized other banks' intensity-only targets, which are compatible with increases in absolute emissions.

mpanies that are ignoring climate science and expanding their operations is the most glaring gap. As the second-largest funder of the fossil fuel industry since the Paris Agreement was signed in 2015, it is a gap that Citi should fill without delay."

The unprecedented: Citigroup's climate plan uses absolute emissions rather than carbon intensity metrics to judge progress in the energy sector. By measuring financed (absolute) emissions to measure its progress in its energy portfolio, Citi breaks rank with three other major US banks (JP Morgan Chase, Goldman Sachs, and Morgan Stanley) that have used carbon intensity metrics in their 2030 net zero plans. The carbon intensity metric is a cheap accounting trick that enables banks to appear as if they are decarbonizing, even as they continue to expand their support of the fossil fuel industry and corporations driving deforestation around the globe. Additionally, Citi is the first US bank to publish its baseline energy sector financed emissions in absolute terms, broken down by scope.

However, the plan still allows for fossil fuel expansion, in direct contrast to the International Energy Agency's assessment. Last year, the International Energy Agency's special report, Net Zero by 2050, concluded that there must be "no investment in new fossil fuel supply projects" starting from 2021 if the world is to avert catastrophic climate change. Instead, Citi's 2030 climate goals include a two year grace period of engaging with their biggest fossil fuel clients to assess their alignment with net zero. Citigroup savs:

Member organizations of the Stop the Money Pipeline coalition released the following statements in reaction to the news:

"With these new commitments, Citigroup has surpassed the low bar set so far by its peers and taken an important first step toward aligning its lending practices with a climate-stable future," said Sierra Club Fossil-Free Finance Campaign Manager Ben Cushing. "The targets Citi has laid out aren't achievable if it continues to fund the expansion of fossil fuel development, and we are hopeful that this assessment period over the next two years will lead to cutting ties with polluters that are failing to change their practices accordingly."

"While an absolute target for energy represents a step forward, Citi has not ruled out expansion of fossil fuels -- sidestepping the headline requirement of the IEA net-zero scenario that Citi's energy target is based on," said

A has underlined the need for decarbonized power by 2035 in the rich world and 2040 worldwide."

"While it's great that Citi is breaking rank with other fossil fuel funding giants by setting absolute emissions targets for its portfolio, they simply cannot continue to allow fossil fuel expansion," said Amy Gray, Senior Climate Finance Strategist at Stand.earth. "Our planet just cannot afford anymore stalling tactics, frontline communities just can't wait for these banks to appease the fossil fuel industry while our homes burn and flood, while our bodies are polluted and our children's futures are destroyed for profit. It's time to set the standard for the banking industry and Citi should step up to the plate and lead the way."

"Citi cannot call itself a climate leader as it continues to pour financing into bil and gas expansion projects in critical biomes like the Amazon," said Pendle Marshall-Hallmark, Climate and Finance Campaigner at Amazon Watch, "Without a clear commitment to end financing for fossil fuels, Citi's new targets fall short. If Citi is serious about aligning its portfolio with its stated values, it must commit to end fossil fuel expansion immediately, in line with IPCC and IEA science."

"With these new 'targets,' Citi is likely expecting praise from the environmental community, but we can't praise any plan that still allows for funding fossil fuel expansion," said Erika Thi Patterson, Campaign Director for Climate and Environmental Justice with the Action Center on Race and

Climate Campaigners Decry 'Absolutely Horrendous' Brutality Against Protesters at Fed Summit

"We have no choice but to take direct action to put our bodies on the line because petitions, sign-waving, and chanting—we tried that for the past 50 years and it hasn't worked, and we're out of time," said one arrested activist.

Climate campaigners on Friday condemned the violent takedown of activists during a demonstration at the annual Jackson Hole Economic Policy Symposium in Wyoming, an elite gathering where U.S. Federal Reserve officials, central bankers from around the world, economists, and policymakers meet, mingle, and craft financial policies that critics say are exacerbating the planetary emergency.

Multiple videos posted on social media by the direct action group Climate Defiance show law enforcement officers slamming a pair of activists on a hard floor as they chant, "End fossil finance" at the conference, which is hosted by the Federal Reserve Bank of Kansas City. This year's theme is "Structural Shifts in the Laboral Economy."

One activist—25-year-old Teddy Ogborn of the group Planet Over Profit—was arrested, while other demonstrators were cited for criminal trespass, according

Eren Can Ileri, a policy advocate at the Stop the Money Pipeline coalition.

"I'm feeling a little sore but in pretty high spirits just thinking about the fact that someone has to be confronting these financial regulators who are actively choosing to fuel the climate crisis and burning the Rocky Mountains, where I'm from," Dgborn told Common Dreams.

"I am part of a global movement of young activists who see the world around us and know that progress is not being made fast enough on climate change," he continued. "People are climate laggards, they are climate delayists, they're climate deniers, and all that together means death in the near term for our futures and society as we know it."

"People want to do business as usual," Ogborn added. "Financial regulators have billionaire friends who want to watch the world burn from space. And so we have no choice but to take direct action to put our bodies on the line because petitions, sign-waving, and chanting—we tried that for the past 50 years and it hasn't worked, and we're out of time."

lleri, who was also at the protest, told *Common Dreams*: "We tried to exert our democratic rights today. We tried to peacefully, nonviolently, and constructively engage the Federal Reserve on policy positions we believe are needed to save our futures. They showed us they were not open to conversation through their violence toward our activists but also by whisking the Fed chair away when we tried to approach him conversationally."

Federal Reserve Chair Jerome Powell once again took a hawkish stance during a speech in which he said that "although inflation has moved down from its peak —a welcome development—it remains too high," and that the Fed is "prepared to raise rates further if appropriate."

Powell did not address the climate emergency or the role central banks play in fueling it. Ileri asserted that "by isolating themselves from communities facing the real economy impacts of the climate crisis," Powell and other central bankers "are allowing themselves to define risk in a way that doesn't match the

sks that normal Americans face on a day-to-day basis due to the climate breakdown."

Stop the Money Pipeline co-director and San Francisco Board of Supervisors candidate Jackie Fielder responded to the heavy-handed police tactics by telling Common Dreams that "it's absolutely horrendous how security and law enforcement would assault young climate activists who are simply calling out climate denialism at the Fed."

The direct action came as a coalition of more than 70 climate advocacy groups from around the world on Friday called on policymakers—especially in the banking and insurance sectors—to:

- Adopt a precautionary approach to risk mitigation, given climate change's tipping points and unpredictable tail risks;
- Design capital buffers that specifically take into account the systemic risks
 of climate change; and
- Require the use of forward-looking tools, such as transition plans, which can help both authorities and market participants better understand and mitigate their own climate-related transition risks, as well as improve understanding of aggregated, systemic risks and promote accountability.

"Any symposium entitled 'Structural Shifts in the Global Economy' without a single mention of climate disasters and the billions they have cost everyday people and local economies should concern every American with a pension who agrees that climate change is here," Fielder said in a separate statement.

Akiksha Chatterji, lead campaigner at Positive Money U.S., a research and campaigning group "working to reimagine money, banks, and our economy for the well-being of people, communities, and the planet," said that "regulators are failing to act at the scale or pace necessary to curb the significant financial stability threats arising from climate change and fossil fuel financing."

"Rest assured, climate risks will materialize and we simply cannot quantify the precise nature and timing of these impacts as they are complex and ever-

hanging," she continued. "Emergency measures taken after a climate-driven nancial crash may not suffice to contain such a meltdown."

"It's time," Chatterji added, "for the regulators and officials at this symposium to adopt a precautionary approach to climate and do their jobs before another financial crisis ensues."

In a Summer of Climate Chaos, Fed Summit Ignores Risk of Climate Crisis to Global Economy

n open letter, civil society groups demand central bankers take immediate climate action

WASHINGTON, D.C. – Today, over 70 international, national and state/local organizations released an open letter to the Federal Reserve and central bankers attending this year's Jackson Hole Economic Policy Symposium. The letter calls on symposium participants to act quickly and vigorously to address recent escalations in climate-related financial risks. In remarks this morning, Federal Reserve Chair Jerome Powell omitted any mention of climate-related financial pasks in his Jackson Hole speech.

The <u>open letter notes</u> that climate-related impacts are outpacing authorities' current efforts to address climate-related financial risks. This is evidenced by escalating costs of physical risks and growing gaps in insurance coverage, among other things.

Policy makers, especially in the banking and insurance sectors, must:

- Adopt a precautionary approach to risk mitigation, given climate change's tipping points and unpredictable tail risks. This could include capital adjustments and other mechanisms to properly reflect the risk of fossil fuel production and thus facilitate a transition;
- Design capital buffers that specifically take into account the systemic risks of climate change;
- 3. Require the use of forward-looking tools, such as transition plans, which can help both authorities and market participants better understand and mitigate their own climate-related transition risks, as well as improve understanding of aggregated, systemic risks and promote accountability.

- 4) Sponsored Project agrees that no funds that it receives from SMF will be used for "carrying on propaganda, or otherwise attempting, to influence legislation" as described in Internal Revenue Code § 501(c)(3); nor for "influencing legislation" as defined in Internal Revenue Code § 4911(d); nor to perform any "lobbying activities" as defined by United States Code, Title 2 § 1602(7).
- 5) Sponsored Project agrees that at no time will any funds it receives from SMF be used to influence the outcome of any specific public election, or to participate in, or intervene in, (including publishing or distributing of statements) any political campaign

on behalf of (or in opposition to) any candidate for public office. Additionally, Sponsored Project agrees that at no time will any funds it receives from SMF be used for any attempt to influence the outcome of any selection, nomination, election, or appointment of any individual to any public office or office of a political organization within the meaning of Internal Revenue Code Section 527(e)(2).

- 6) Sponsored Project agrees that expenditures made with funds provided by this agreement will not be used in any way that may constitute an Excess Benefit Transaction as defined by Section 4858 of the Internal Revenue Code, nor to be used in any way that may constitute private inurement within the meaning of the Internal Revenue Code Section 501(e)(3).
- 7) Sponsored Project agrees to use any and all funds received from SMF solely for regitimate expenses of the Project, and to account fully to SMF for the disbursement of all Funds received from SMF upon request. In addition to a financial accounting of funds received from SMF, the reports from Sponsored Project will include a narrative description of the status and accomplishments of the Project.
- 8) Five percent (5%) of all amounts received for the Project account, plus direct out of pocket expenses such as wire fees, other bank fees, and express delivery charges, will be retained by SMF to defray SMF's costs.
- 9) Sponsored Project agrees not to use funds from SMF in any way which would geopardize the tax-exempt status of SMF. Sponsored Project agrees to comply with any written request by SMF that it cease activities which might jeopardize SMF's tax status or result in adverse consequences to SMF.
- 10) Sponsored Project agrees to use its best efforts to carry out the Project's purposes. Sponsored Project will advise SMF of any proposed material changes to the Project and will not make any changes without the prior written consent of SMF.
- 11) Sponsored Project agrees to return to SMF any funds received from SMF that are not expended in accordance with the terms of this agreement.
- 12) Sponsored Project agrees to defend and indemnify SMF, and SMF's officers, directors, trustees, employees, and agents, from and against any and all claims, liabilities, and expenses (including reasonable attorneys' fees) arising from any act or omission of Sponsored Project, its officers, directors, trustees, employees, or agents relating to this agreement or the use of the funds provided by virtue of this agreement, except to the extent that such claims, liabilities, or expenses arise from any act or omission of SMF, or as officers, directors, trustees, employees, or agents.
- (3) All funds, now and hereafter, disbursed to Sponsored Project by SMF for the Project will be in accordance with the conditions herein. SMF retains the right, in the event of a breach of this Agreement by Sponsored Project, or if Sponsored Project's conduct jeopardizes SMF's legal or tax status, to terminate its fiscal

sponsorship of Sponsored Project, and to thereafter expend the Fund to accomplish the charitable, scientific, literary or educational purposes of Sponsored Project as nearly as possible within SMF's sole judgment.

- (4) This Agreement shall not be deemed to create any relationship of agency, partnership, or joint venture between the parties hereto, and neither party will make such representation.
- (5) This Agreement is governed by, and will be construed and interpreted in accordance with the laws of the State of New York.

This is the entire agreement between Sponsored Project and SMF and may be modified only by written agreement between Sponsored Project and SMF. Sponsored Project acknowledges that it is not relying on any representation of SMF, except as set forth in this agreement, and no representations that may have been made by SMF in the past survive.

Director Arntz;

This letter is to challenge Jackie Fielder's Proposed Ballot Designations for District 9 Supervisor of:

- Director, Climate-Action Nonprofit
- Director, Environmental Nonprofit
- Director, Climate Nonprofit

Per Section 20714(a)(3) of Title 2, Division 7, Chapter 7 of the California Code of Regulations:

 "Occupation" means the employment in which one regularly engages or follows as the means of making a livelihood."

Fielder states clearly on her Form 700 that her main source of income does not come from being a 'Nonprofit Director' of any sort; in fact she states her main source of income is her ownership of her for-profit company: Dawn Media, LCC. She states that she has been paid over \$100,000 by her for-profit entity.

Yet in her proposed Ballot Designations, Fielder claims she is some variation of a Nonprofit Director. However, the nonprofit she claims to make a livelihood from, Stop the Money Pipeline, was not even listed under the section of her Form 700 identifying reportable sources of income of \$10,000 or more.

The sole source of reportable income to Dawn Media that she listed was an entity called 'Sustainable Markets Foundation'. The Sustainable Markets foundation is not even found on the coalition page of Stop the Money Pipeline's <u>website</u>. Additionally, Stop the Money Pipeline is not even a 501(c)3 registered nonprofit, further contradicting her claim.

Fielder is violating the spirit and intent of the law by fraudulently attempting to use a ballot designation she believes will benefit her in the upcoming election.

Allowing Jackie Fielder to claim to be a Nonprofit Director by her claiming the mission of her for-profit corporation's clients opens the door to corporate CEO's to misrepresent their work to have greater appeal to voters. News outlets repeating her claims of being a director of an entity that does not exist as a nonprofit does not negate the legal requirements necessary for a ballot designation.

In summary, Jackie Fielder **does not** make her livelihood from being a Director of a Nonprofit, she makes it from her for-profit media company. Her own Form 700 disclosure demonstrates this. She makes her livelihood by being the sole owner of a for-profit media company and her ballot designation should reflect that fact. Either her Form 700 or Proposed Ballot Designations are a lie. Whichever the inaccuracy is, it should not be perpetuated.

Summation of Facts:

- Jackie Fielder's sole source of income and livelihood is Dawn Media, LLC, a for-profit media company.
- By her own admission on her Form 700, Jackie Fielder does not make her livelihood from running or directing any nonprofit.
- Stop the Money Pipeline is not a 501(c)3 nonprofit.
- Assuming the above can somehow be reconciled, she has only provided limited proof of payment to her for-profit entity that her work was primarily for Stop the Money Pipeline.
- The largest source of income for her for-profit entity, Sustainable Markets Foundation, is not even listed as a coalition member of Stop the Money Pipeline.
