Highlights for October 16, 2024

The following report includes the Department of Police Accountability's recent developments:

- ◆ Director Henderson and staff members are currently attending the National Association for Civilian Oversight of Law Enforcement annual conference.
- ◆ The **Audit Division** has scheduled an exit conference with SFPD on October 28th.

Investigation Updates

- ◆ **Cases Opened/Closed:** Our office opened 16 new cases and closed 13 cases since the last Commission meeting.
- ◆ **Allegation Trends:** 65% of the complaints in the past week related to "Neglect of Duty."
