Furthermore, if the City does not receive your response letter by **July 7, 2024**, or is not satisfied with the response, your organization is at risk of being placed on elevated concern status. Elevated concern is a designation by the City indicating a nonprofit has not responded to the City's request for monitoring documents, has not responded to the City's request for corrective action, has not provided a corrective action plan that is acceptable to the City, or has not complied with the implementation of its corrective action plan.

Once a nonprofit is designated as elevated concern, the agency may become less competitive for new grants or contracts from the City. Nonprofits remain on elevated concern status until a satisfactory corrective action plan is received and implemented to funding City department(s).
