

Project Title: Proposed Amendments to Regulation 8: Organic Compounds, Rule 8: Wastewater Collection and Separation Systems

Project Location: The rule and proposed amendments apply within the Bay Area Air Quality Management District ("Air District"), which includes all of Alameda, Contra Costa, Marin, Napa. San Francisco, San Mateo, and Santa Clara counties, and the southern portions of Solano and Sonoma counties.

Project Description: The Air District has regulatory authority over stationary sources of air pollution in the San Francisco Bay Area. The proposed amendments to Regulation 8, Rule 8 (Rule 8-8) address emissions of volatile organic compounds and methane (together referred to as "total organic compounds") from wastewater collection and separation systems at industrial facilities in the Bay Area. The proposed amendments would enact more stringent best available retrofit control technology (BARCT) levels at the refinery wastewater treatment systems by increasing frequency of leak inspections, updating leak detection methodologies and standards to include a wider range of organic compounds (including methane), and strengthening protocols for repairing and minimizing leaks. The amendments also include a number of other changes to improve enforceability of the provisions and expand sampling and monitoring requirements. The Air District has prepared a Staff Report that provides a summary of the rationale for the rule amendments. Background information and analysis is also available in the Staff Report. The proposed amendments and Staff Report are intended to provide the public with information in advance of a Public Hearing.
